2025 VOLUNTEER FEES POLICY

While there are no membership fees for our volunteers, it is important to note that there are some personal financial commitments to this volunteer activity. There are 4 main categories of financial commitments to participate in the Troopers Legacy Corps.

- 1.) Fees associated with DCI abuse prevention requirements (i.e. background check, abuse prevention training, etc.)
- 2.) Travel expenses (i.e. air or ground travel to/from event, housing, some meals, personal expenses such as tickets to watch the DCI Semi-Finals/Finals shows)
- 3.) Personal equipment you may need to perform in your volunteer capacity
- 4.) Expenses to participate in pre-event camp(s) (if applicable)

As a registered volunteer, the Troopers Legacy Corps will provide at no charge selected bus fees to transport members and volunteers during the event week, selected meals (same as members' meals), and a volunteer event shirt. For accounting purposes, an "in-kind" donation will be made to the corps in your name upon your registration in recognition of the time you give to help. All volunteers are subject to the same contractual requirements (i.e. behavior expectations, anti-harassment training/requirements, child safety requirements, etc.) that are required for performing members.

Nonetheless, and despite every effort we can make, injuries can and do occur, and the Troopers Legacy Corps will immediately address and care for every volunteer who is injured or suffering any illness. Participation in these activities is entirely voluntary and requires volunteers to follow instructions and abide by all applicable rules, policies, instructions, and manuals, as well as the Troopers' Code of Conduct.

By executing these documents as part of the registration process, I acknowledge and agree on my own behalf and I understand that participation in the activities of the Troopers Legacy Corps involves the risk of personal injury, including severe injury or even death, due to the physical, mental, and emotional challenges and demands of the activities offered.

I understand that I am responsible for paying all medical bills that may arise during my participation in the Troopers Legacy Corps.

I further acknowledge and agree that I have been provided in advance, read and reviewed this Informed Consent, Release Agreement and Authorization, the Troopers' Health and Safety Policies and the Codes of Conduct mentioned above, and all other materials provided to me by the Troopers.
