 - These risks may include, but are not limited to: sprains, strains, fractures, concussions, paralysis, and in rare cases, death.
 - The participant voluntarily engages in these activities with full knowledge of the risks involved.

2. Release of Liability

In consideration for receiving services from Karma Choreography:

I, the undersigned, hereby release, waive, discharge, and hold harmless **Karma Choreography**, its coaches, staff, agents, and subcontractors from any and all liability, claims, demands, or causes of action for injury, property damage, or other losses resulting from participation in cheer-related activities.

Karma Choreography reserves the right to remove any participant from programming due to unsafe or inappropriate conduct.

Participants should not attend any practice or clinic while experiencing symptoms of illness. Karma Choreography follows current health guidelines and reserves the right to modify activities based on public health conditions.
